Re: CIVIL PENALTY ACCREDITATION SCHEME

We are pleased to let you know that the accreditation status has been renewed following a recent review.

Please note that we are no longer including an expiry date on Accreditation certificates. However, your company's status will continue to be reviewed on a regular basis, especially if clandestine entrants are carried by one of your company's vehicles.

It is important that you continue to operate an effective system that includes the appropriate training of drivers, along with the provision of written instructions, security devices and checklists to your drivers as well as monitoring your drivers to ensure that you are complying with the requirements to run an effective system.

Membership of the scheme

A penalty may be imposed on your company if we discover that your system in place at the time of an incident differs from that which was described to us at the time of your application to join the scheme, or if it is no longer effective.

If we discover that false information was presented to gain accreditation to the scheme, we reserve the right to impose a penalty on your company and revoke your accredited status.

We will inform you of any incident regarding the discovery of clandestine entrants in your vehicles so that you can review your system. It is important that you reply to any correspondence sent to your company in relation to any incident.

May we also remind you that you are joint and severally liable for any penalties that are imposed upon the drivers you employ. Failure to pay a penalty imposed upon one of your drivers by the due date will result in your vehicles being liable to detention and your company's accreditation status may also be revoked.

To remain a member of the Accreditation scheme, you must advise us of any changes to your company's operating address and contact names.
